## Syllabus

The course prepares you for the PPCDL issued by the Maritime and Port Authority (MPA) of Singapore. It covers everything you need to know about driving a powered boat.

From theoretical topics like sound and light signals and the right of way (not unlike the highway code for driving on the road) to actually going behind the wheel and driving the boat.

## Course Schedule

The course is conducted with a minimum of 5 participants. A complete course runs over one weekend. Please refer to course schedule.

## Training Session

Saturday and Sunday classes are divided into half-day theory & half-day practical lessons, from 0915hrs to 1730hrs.

## Theory Lesson

Nautical terms, safety and boat equipment, chart reading, Ports and Pleasure Craft regulations, bouyage system, emergencies at sea and Regulations for the Prevention of Collision at Sea.

## Practical Lesson

Practical boat handling training at sea on steering, man-overboard recovery, slipping off & berthing, collision avoidance, anchoring & basic navigation.

## Free Revision

Students are welcome back for free theory revision classes, unlimited for a year. Practical revision is also available at S\$90 per hour.

## Instructors

All instructors are SMA certified trainers with Master Mariner, Naval Officer or Royal Yachting Association (RYA) Yacht Master qualification.

At the end of the course, trainees will be awarded a Certificate of Attendance. This certificate is required for the tests conducted by Singapore Maritime Academy (SMA).

## Test Centre

Theory and practical tests are conducted by SMA on its premises at Singapore Polytechnic. On successful completion of both the theory and practical tests, candidates will be issued with a license by MPA.
